

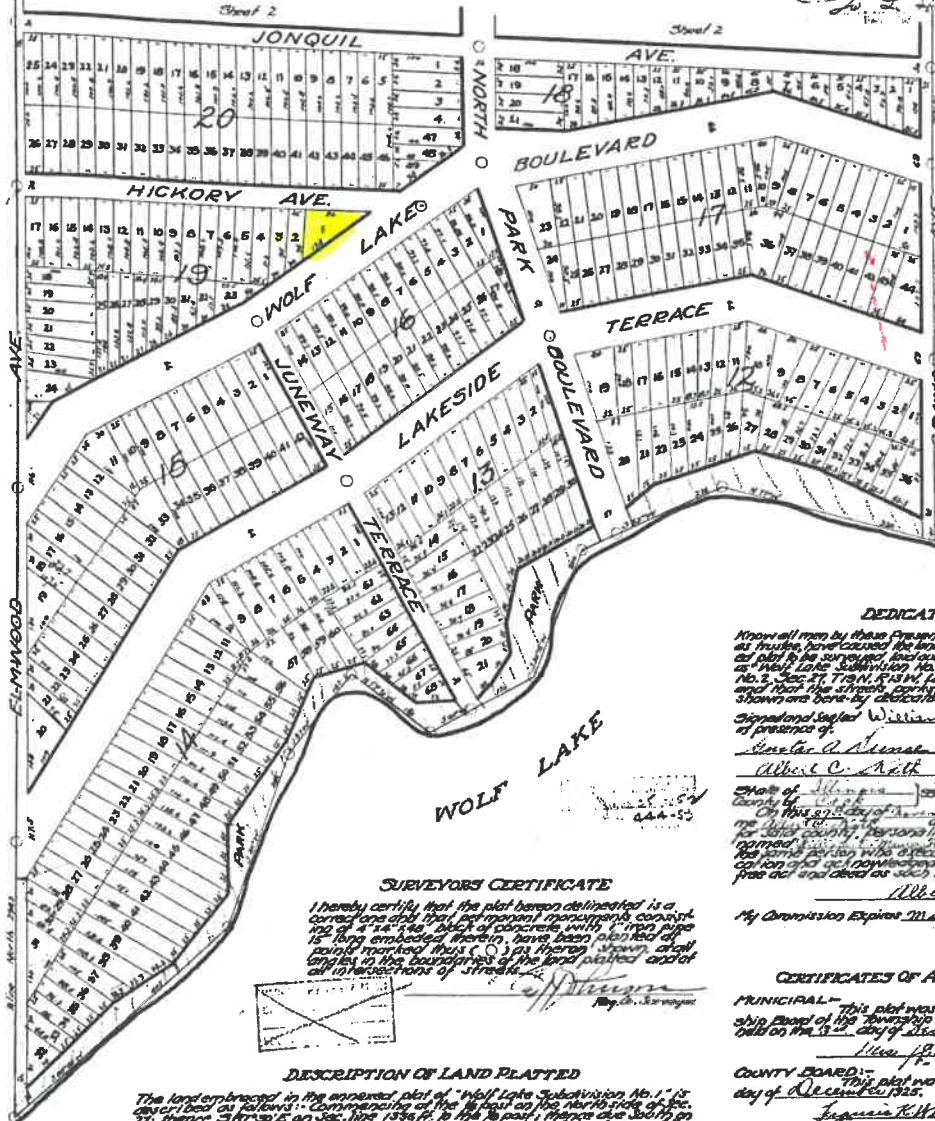

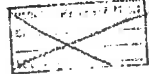

### SURVEYORS CERTIFICATE

I hereby certify that the plat herein delineated is a  
correct one and that the permanent monuments consisting  
of 4" x 4" x 1/2" blocks of concrete with 1/2" iron pipe  
long embedded therein, have been placed at  
points marked thus (O) on thereon shown and  
affixed to the boundaries of the land platted except  
at the intersections of streets.



### DESCRIPTION OF LAND PLATTED

The land embraced in the annexed plat of "Wolf Lake Subdivision No. 1" is

a corner; thence S 87° 10' 00" W 138.11 ft. to the 1st 1/2" pipe; thence due North  
on 1/2" line 225.11 ft. to the place of beginning.
